

Absentee Ballot Request Form

you may use this form if:

- you are registered to vote and
- you will be away from your home address during an election

The post office will not forward your ballot from your home address.

Possible reasons for requesting an absentee ballot include:

- you will be on vacation during an election
- you are a college student living away from home
- you live part of the year in an-other state (e.g. snow bird)



If you are serving in the Armed Forces, the Merchant Marine or are temporarily living outside the territorial limits of the United States, you must fill out a:
