HOOD RIVER COUNTY PUBLIC WORKS REQUEST FOR PRICE QUOTES HOT MIXED ASPHALT CONCRETE May 5, 2020

Hood River County Public Works (County) is requesting sealed price quotes to furnish Hot Mixed Asphalt Concrete (HMAC) for the 2020 paving season.

HOT MIXED ASPHALT CONCRETE SPECIFICATIONS

1. The hot mixed asphalt concrete shall conform to the specifications for 3/8" Dense Graded Level 2 HMAC and 1/2" Dense Graded Level 2 HMAC, Section 00744 – Asphalt Concrete Pavement, Hot Mixed Asphalt Concrete Pavement, Oregon Department of Transportation (ODOT) Oregon Standard Specifications for Construction 2018".
2. The price provided shall be for delivery by the supplier onto transport at the plant in County owned trucks, or contracted trucks furnished by the County.
3. The County reserves the right, before acceptance at the point of delivery, to inspect the materials and ascertain that all specifications set forth herein are fully met.
4. This Request for Price Quotes is for materials to be purchased between June 1, 2020 and July 31, 2020. Upon mutual agreement by the County and the supplier, the submitted prices may be extended for up to 60 days.
5. The estimated quantity of 3/8" HMAC to be purchased by the County is approximately 300 tons. The estimated quantity of 1/2" HMAC to be purchase by the County is 2,800 tons. The County reserves the right to purchase any, all, more, less, or none of the estimated quantities.
6. Before and after a HMAC supplier is selected for the 2020 paving season, the County reserves the right to purchase HMAC from another supplier if it is temporarily unavailable from the selected supplier, if the material fails to meet the specifications or standards during the course of the season, or upon any finding by the County that it is in the County's best interest to do so.
7. In comparing price quotes for selection, the County may consider a haul and standby cost of \$0.42 per ton, per mile, measured round-trip from the supplier's point of delivery to the Hood River County Public Works office at 918 18th Street in Hood River, Oregon, based on the County's preferred choice of travel.

The County assumes no responsibility for any delays in USPS mail service, any other carrier service, or for any unforeseen road closures or related delays that result in a price quote being received late.
5. The County will select the Supplier whose price quote will best serve the interests of the County while taking into account considerations including, but not limited to, experience, expertise, product functionality, product availability, and suitability for a particular purpose.
6. No material deviation from the Specifications contained herein will be accepted; however, the County reserves the right to waive non-material deviations from the Specifications.
7. The County may reject any price quote not in compliance with all prescribed public purchasing procedures and requirements, and may reject for good cause any or all price quotes upon a finding by the County that it is in the County's best interest to do so.
8. Price quotes received after the specified due date and time will not be returned.
